Each Affiliate Partner is assigned a personal URL which you place on your web site or include in e-mail or some other vehicle when recommending the product to someone. From each sales coming from that URL, we'll pay you a 15% commission. Commissions are paid on a monthly basis.

Terms and conditions:

1. Affiliate Partner shall provide a link from its Site to CS Odessa's Site as approved by CS Odessa.

Affiliate Partner shall be responsible for the development, operation, and maintenance of its Site and for all materials that appear on its Site.

2. CS Odessa shall be responsible for all aspects of the Customer relationship, including order processing and fulfillment, cancellations and returns, and technical support.

3. CS Odessa will provide Affiliate Partner with an ability to view their sales reports online.

4. CS Odessa will pay Affiliate Partner a 15% commission for each purchase of CS Odessa's products, coming from Affiliate Partner's web site. The commissions are exclusive of costs for shipping, handling, taxes and service charges.

5. CS Odessa will inform Affiliate Partner of any price changes of its products sold through Affiliate Partner.

6. CS Odessa will pay Affiliate Partner on a monthly basis, approximately fifteen (15) days following the end of each month, for the commissions earned on sales of CS-Odessa products that were shipped during that month. If the commissions are less than \$100.00, CS-Odessa will hold them until the total amount due is at least \$100.00. If a product that generated a commission is returned by the Customer, CS-Odessa will deduct the corresponding commission from Affiliate Partner's next monthly payment.

7. Partnership may be terminated by either party at any time upon written notice with or without cause. In this case, Affiliate Partner shall immediately cease use of, and remove from its Site, all links to CS Odessa's Site, and all CS Odessa trademarks and logos, and all other materials provided by or on behalf of CS Odessa to Affiliate Partner.
